WHO WE ARE

The Intentional Community Consortium (ICC), founded in 2017, is a registered not-for-profit, representing charities and not-for-profit organizations, working to solve the housing crisis for those with diverse abilities across Canada.

- Mission:** Affect change by applying shared learning and networking from our member organizations to:
- Expand affordable housing projects for mixed use.
 - Combine the strength of our member organizations to create hundreds of housing units throughout Canada with a preference for multi-unit projects of 20-units or more.
 - Advocate as a consortium to all levels of government.
 - Share tools and information through partnerships and member engagement.

- About 100,000 Ontario adults have an intellectual disability. An estimated 40% (40,000) of these individuals also have a concurrent mental health diagnosis.
- An estimated 14,000 Ontario individuals with an intellectual disability are on a non-municipal waiting list for residential housing with a projected (forty) 40 year wait list.

Our Ask

Federal



- Federal investments through co-investment fund reflect updated costs as inflation, financing and other market forces add costs particularly for the deeply affordable supportive housing development.
- Establish a dedicated pathway for deeply affordable and supportive housing like ICC, that will generate secondary benefits to the community including reduced health costs, and related social and policing supports.

Provincial



- Provincial investment in housing for individuals with developmental disabilities by earmarking 10% of the National Housing Strategy funding to this critical need, and requiring municipalities to commit accordingly.

Municipal



- Partner with local agencies serving those with developmental disabilities to quickly build more housing.
- Establish an equitable assignment of land, funds, and resources for affordable, accessible and supportive housing for individuals with developmental disabilities.
- Ensure favourable zoning to allow for more inclusive communities providing affordable, accessible and supportive housing.

BUILDING THE FUTURE – OUR MEMBER PROJECTS

The supply of affordable, accessible, and supportive housing for people with diverse abilities remains far less than the need. A home of one's own is the cornerstone of independence for ALL persons.

COMPLETED PROJECTS



KW Habilitation modular structure built for 2 adults. So many possibilities with modular structure can fit in a backyard or stacked as apartment units.



CAFFI Housing collaborated with Raising the Roof to restore a heritage building as an affordable rental, piloting an innovative home-share model.

FUTURE PROJECTS



Reena's 3rd Intentional Community, the Frankfort Family Reena Residence in Toronto will have 111 self contained rental apartments for 168 tenants.



Community Living Toronto's Lawson development in Toronto will be designed to be inclusive, accessible, and transit-friendly, making it easy for everyone to get around and participate in the community.
